The board has also formed multiple committees to execute the business plan. (Details enclosed in Annex I)

2. Dues are to be paid by the immediate past board (claimed by Ram C. Kharel).

Mr. President explained about the dues; he mentioned that the dues were since 2014, that was the tenure of Mr. Khagendra GC, and the expenses were incurred without consultation to the contemporary board. The board unanimously declined to pay the dues that Mr. Ram C. Kharel claimed.

3. Mohan Narayan Memorial Fund transfer (requested to transfer by donor) The request letter is enclosed in Annex III.

The board has unanimously passed the transfer of the “Mohan Narayan Memorial Fund” that is the US \$9,254.68 to the “SANGASAGAI” New York 501 (c) 3 Organization (EIN 81-2507405), as the donor requested it to transfer.

4. Clarification Letters Issued by General Secretary

- Krishna KC

Mr. General Secretary has issued a letter to Mr. Krishna KC, asking for clarification regarding his article published on hollywoodkhabar.com on 8 Nov 2018, where he wrote, “NRNA NCC USA is the worst among the 78 countries NCC”. Mr. KC emailed Mr. General Secretary using the odd (nasty) words of his clarification instead. (Email screenshot enclosed in Annex IV.) After a wide discussion, the board reached the conclusion that Mr. KC’s activities should be considered a violation of NRN USA’s bylaws, Charter and acted against purpose and objective of NRN USA’s bylaws. He did not submit a clarification letter as well. Therefore, the board has unanimously decided to refer this case to the “Disciplinary Committee” for further proceeding.

- Priti Khatri

Mr. General Secretary has issued another letter to BOD Mr. Priti Khatri regarding his political support during the Nepal Election. Within the given time frame, Mr. Khatri has submitted the clarification letter to the board and he stopped the activities he was doing. After due consideration of the case, the board has unanimously decided to eliminate the issue.

5. Any Other Business (AOB)

- INLS International Convention & Financial Support

As a courtesy to the globally known organization, the board has unanimously decided to allocate USD 1,000.00 financial support to the INLS International Convention that is going to be held on the first week of June 2018 in Washington, D.C. The INLS has requested it to the ICC, and ICC forwarded it to us because of it happening in our region. (The request letter is enclosed in Annex V)

- **Visa Sponsor Letter requested by World Cyclist Mr. Gyan Lal Maharjan**

After a long discussion on the matter of Mr. Gyan Lal Maharjan's (a world cyclist, according to him) visa sponsor and invitation letter request, the board unanimously decided not to provide such a letters to anyone except to immediate family members of deceased/victim for funeral events of US residency NRNs and to the VIPs of NRNA guests during the NRNA NCC USA's special conference.

- **Advisory Committee.**

Mr. Senior Vice President has moved to give the authority to the president to select the advisory committee, and the general secretary has seconded it. After a brief discussion, the board has unanimously passed the motion. Now, the president has the authority to select the advisory committee by consulting every board member. The chosen advisory committee members' names will be submitted to the board at the next meeting for final endorsement.

- **Providing members data to the chapters**

The board has decided to give the name and email address of respective chapter members to the separate chapters for official communication with the responsibility of Chapter President, and not to provide other details (e.g., Phone#, address, etc.) due to privacy matter.

It has been some time since your re-election. I hope that you can lead NRN NCC USA to a successful closure of this issue.

You are well aware from my previous letters of the Mohan Narayan Shrestha Memorial Fund, named for my late husband, which NRN NCC, USA holds but which I have requested, since February last, be transferred to Sangsangai, a New York 501 (c) 3 organization (EIN 81-2507405), that just completed rebuilding a village in Lamjung.

This money is earmarked for the construction of the Mohan Narayan Shrestha Memorial Community Center in Barabundi, Kavre.

I know this was an issue in the past executive and in order to get an expert opinion and to help clarify any associated issues, we had outside legal counsel review the matter. As I understand it, the by-laws do not appear to prohibit a transfer, and a Board resolution could suffice to release the funds. I request that at the next executive meeting you will approve this such a transfer.

Sangsangai laid the cornerstone for the Center on May 1st, in a celebration attended by several of my family in Nepal. I am quite concerned that the work has been so delayed, and Sansangai is anxious to move forward. Attached is a summary overview of

the Memorial. As you can see, I have underwritten the full project based on the reliance that I can depend on NRN NCC USA for nearly half the expense.

We recently raised some of the additional funds required and initiated construction at the site. I intend to fulfill my pledge to see the Memorial completed. I am counting on your help.
