July 8th, 2023-Second Candidates list publication upon review by the EB.

<u>July 9th, 2023</u>- by noon (12 PM) <u>EST</u> – Withdrawal of any Candidacy (No extension after that). <u>July 11, 2023</u>--Final Candidates list publication for the ballots.
