Summary of ICC delegates election Process

गैरआवासीय नेपाली संघ राष्ट्रिय समन्वय परिषद (एनआरएनए एनसीसी) अमेरिकाबाट संघको अन्तराष्ट्रिय परिषदको १० औं विश्व सम्मेलन तथा अन्तराष्ट्रिय महाधिवेशनका लागि संघको निर्वाचन आयोगद्वारा २५ प्रतिशत प्रतिनिधिको लागि चयन गरिएको प्रक्रियाको सारांस यहाँ प्रस्तुति गरिएको छ।

संघको अन्तराष्ट्रिय र राष्ट्रिय समन्वय परिषदहरू दुबैको बिधानका प्राबधान अनुसार यो निर्वाचन गरिएको हो। अमेरिकाबाट प्रतिनिधित्व गर्ने जम्मा १८९ जना प्रतिनिधि मध्ये निर्वाचनबाट २५% ले हुन आउने ४७ जनाको नामावली पनि यसैसाथ समावेस गरिएको छ।

Summary of ICC delegates election:

- 25% selection was based on NRNA NCC-USA mandate given to Election commission. Election commission had considered all the relevant articles from ICC and NCC By-laws.
- June 10, 2021: Election commission had a meeting and raised some concerns regarding 25% delegates election as there were no rules/guidelines.
- June 14, 2021: Election commission forwarded its minutes to all the concerned people including newly elected board.
- June 19, 2021: General Secretary Pasupathi Pandey sent an email to the election board with some guidelines/order but did not address the concerns that the election commission has raised and shared with them for the resolution.
- June 19–21, 2021: After not getting any proper guidelines/rules on concerns raised, the election commission contacted the patrons, some state chapter presidents and some of the newly elected executives and board members and then collected their opinion. Based on that Election commission had discussed and proposed the election modality considering both ICC and NCC by-laws.
- Modality was made considering the following articles of the by-laws:

ICC Niyamawali-2021 regarding Delegates selection: 6.2.kha.

NCC By-laws Articles: 28, 54.a,b,c,d; 152;153; 157.c.II

- June 23: Election Commission shared the election modality to all the concerned people from ICC to NCC, Media and public for their opinion and requested them to provide their opinion by June 24th 5:00PM EST.
- June 24th:
 - -Some of the Newly Elected executives and Chapter presidents accepted our proposal.
 - While discussing with the patrons, found out that they had suggested the similar modality to the board sometime in May 2021 but the President and General Secretary never shared it to the board and election commission.
 - Very few people were not agreeing on our modality, but they were not giving any alternative solutions which comply with the ICC and NCC by-laws.
 - Just before our timeline, president Suneel Sah sent an email to not to publish any notices regarding ICC delegates election.
 - Election committee analyzed all the responses and concluded to continue the election.
 - Most of the concerned people accepted the modality.
 - The Election Commission had very limited time as AGM was approaching.
 - The Election Commission had seen a couple of other email threads where there was conflict of interest and some of the board members were trying to blame the election commission.
- June 24th: Election Commission published the notice regarding the ICC Delegates election with the schedule. Election date was set for July 1st, just before the AGM. The Election Commission also requested the secretariat to share the information, but the secretariat never sent mass email to the members.
- June 25th: General Secretary Pasupathi Pandey sent an email to the election commission saying that the board had formed the three members committee and tried to oversee the election commission.
- June 25th: Election commission sent email to all the officials stating its concerns regarding the general secretary's email.
- June 26th: Election commission collected the nomination forms and published the initial candidates list
- June 27: Election commission sends email – saying that President and General Secretary are not cooperating to conduct the election and they have conflict of interest.
- June 27: President Suneel Sah sent email to hold the election referring to ICC president and general secretary's letter
- June 28: Election commission sent notice to the public saying that the election has been postponed until further notice.
- August 11: President Buddi Subedi sent an email to resume the election based on ICC's request.

- August 11: Election Commission published the notice saying the election was resumed. It published the final list which was about to be published on 6-27-2021. Election commission also asked the NCC secretariat to collect the list of elected delegates from each of the chapter boards and send it to the election commission by August 14th, 2021.
 - August 13: Election completed, and result was published in front of executives (zoom session) and Facebook live.
 - August 14: Delegates list from State Chapters received from the NCC Secretariat.
 - August 14: Send the elected delegates list to ICC Secretariats.

Member Absent: *Govinda Shrestha* (*Mr. Shrestha*, however, upon conclusion of meeting seconded and approved the NRN election commissioner's discussed agenda in writing without dissent)

Approval of minutes:

- a. **Approved minutes** from *June 10, 2021*, meeting of NRN USA election commission
- b. **Motion carried by:** Chief Election Commissioner, *Biswa Nath Baral*
- c. Resolved motion and all minutes from the meeting *on June 10, 2021*, approved without modification and any dissent.

Motion carried and approved without dissent:

1. Current *NRN USA bylaws and ICC bylaws both* do not prioritize election commissioners to participate as ICC delegate under 65% criteria. With these gaps of bylaws, NRN USA election commissioners appear to be limited only for conducting NRN election and are further forced to become ICC delegate candidates through the election process if they so wish to become ICC delegates. However, possible participation by any election commissioner for ICC delegate election as a candidate would carry possible conflict of interest between his performances as ICC delegate candidate and role as an election commissioner. As such, election commission strongly urges to the current NRN National Coordination Council, USA to resolve this problem, prioritize election commissioners as ICC delegate with a proper coordination with ICC, approves our demand in writing and officially notifies the election board before we move forward to conduct ICC delegate

election in efficient, effective, and transparent manner as per NRN bylaws and ICC and prior to ICC's final deadline of *August 15, 2021, for the delegates list*. Unless Election Commissioners are not prioritized as ICC delegates and these issues are not promptly resolved within 65% criteria, Board will be unable to work as an independent commissioner to conduct the fair and transparent election. Election commission forwards this issue to NRN National Coordination Council, USA and urges to resolve promptly before the ICC delegate election. **Result**: Seconded and passed by the election board without dissent.

2. All ICC delegate candidates must prove that they are able to travel to Nepal without any limitations and restrictions. Qualified travelers include US Citizen with valid passport holders, permanent resident card holders, certain qualified valid business, and employment visa holders with no travel restrictions from the date of filing candidacy of ICC delegate to conclusion of ICC election. **Result**: Seconded and passed by the election board without dissent.
3. Motion carried for elected NCC board and chapter presidents *RELEVANT* concern about their possible participation as an ICC delegate. Election commission forwards this issue to NRN National Coordination Council, USA and urges to resolve promptly before the ICC delegate election. **Result**: Seconded and passed by the election board without dissent.
4. Motion carried for proportional representation from each state – based on number of memberships—minimum one delegate--from each State chapter. Election commission forwards this issue to NRN National Coordination Council, USA and urges to resolve promptly before the ICC delegate election. **Result**: Election Commission will further review this agenda upon correspondence with NRN NCC-USA.
5. Motion carried for required number of ICC delegate seats for the election. Election commission forwards this issue to NRN National Coordination Council, USA and urges to resolve promptly before the ICC delegate election. **Result**: Seconded and passed by the election board without dissent.
6. Motion carried for ICC delegate's fee – (*i.e.65% and 25% and 10%*). Election commission forwards this estimated fee ratio to NRN National Coordination Council, USA. **Result**: Seconded and passed by the election board without dissent.
7. Motion carried about 25 % criteria for the ICC delegates election--the election board recently received an email correspondence from newly elected NRN USA president-elect *Mr. Buddi Subedi* concerning the upcoming election for 25% delegates of the ICC. Election board needs a mutual understanding between outgoing and incoming presidents on the election process and forwards this issue to NRN National Coordination Council, USA and urges to resolve

promptly before the ICC delegate election. **Result:** Seconded and passed by the election board without dissent.

8. This 25% criteria election process of ICC-delegate is one-of-a-kind elections in NRN USA's history and happening first time in the States. This election process is entirely different than the NCC, Chapter or ICC members election. However, election commission has been unable to receive any specific guidelines and rules as of this meeting to conduct the ICC delegates under 25% criteria. Election commission forwards this issue to NRN National Coordination Council, USA and urges to resolve all these issues promptly so that Election Commission may initiate the ICC delegate election process. **Result:** Seconded and passed by the election board without dissent.

ADJOURNED:

With no further agendas to discuss, the meeting was adjourned at 9.35PM.

Adopted by the satisfied quorum of NRN USA election board during the election board meeting and seconded by the absentee commission member Mr. Shrestha following upon discussion of agendas of the concluded meeting.

Election Procedures/Modalities for the ICC Delegates (2021)

Pursuant to NRNA NCC-USA Bylaws (2010-with 15th Amendment, 2020, Including Sections: 157.C (I-V); the special authority granted to the Commission under Section 153; specific. ref. of NRNA ICC Bylaws 2003 (with amendments in 2021, Section 13.7 relating to the ICC delegates election)), including vested authority granted in the *Commission* by the AGM pursuant to NRNA NCC USA bylaws, and delegated power assigned from the *Board* to the *Commission* for the ICC delegates, we have come-up-with the election modalities and procedures below that comply with the relevant legal provisions. Importantly, the *Commission's* balancing approach to the ICC delegates election process ultimately offers a practicable resolution for all concerning parties involved with the process. While offering and attaining this method, we have reviewed the *Board's* email, NRNA NCC USA bylaws, applicable *ICC* provisions and “*Et al*”:

1. **Total Number of ICC delegates to be elected pursuant to 25% Criteria: 47** (Source: Numbers Endorsed from the NRNA NCC-USA Board).

2. **Pursuant to NCC bylaws OR ICC bylaws provisions:**
 - A. Each state will have the right to send one delegate to the ICC. Therefore, as a part of the *ICC* delegates election process, the *Commission* will allocate “ONE” ICC delegate for each State Chapter (*totaling of 29 State Chapters*) for this process. The newly elected *State Chapter Board* may nominate and submit the name to the *Commission* for the final endorsement.

 - B. The remaining 18(*Eighteen*) delegates will be selected through the direct voting process. The allocation of these delegates will be based upon the aggregate voting members of each region below:
 - South: 5
 - North-East: 5

3. This ICC delegates election will be based on the regional basis ONLY. The registered eligible voters in each specified region above will select and or cast their votes to the designated ICC-delegate candidates.
