Please read the important information before filing complaint with the NRNA NCC-USA election commission. Pursuant to NRNA NCC-USA bylaws, the election commission has sole jurisdiction to adjudicate alleged complaint in terms of eligibility of any election candidate. In compliance of the election commission's policy and guidelines, a person who wishes to file a complaint against the candidate **MUST BE A CANDIDATE FOR THE SAME POSITION at national, regional, local or ICC.** Complaint filed by any other *CANDIDATE OR NON-CANDIDATE* than the *CANDIDATE* who is filing for the candidacy for the same position at national, regional, local or ICC position will be **DIRECTLY** rejected BY THE ELECTION COMMISSION. In addition, the complaint must specifically state the alleged complaint/violation and the person is responsible for the complaint/violation.

IMPORTANTLY, this written sworn complaint form ***MUST BE SIGNED IN FRONT OF A NOTARY PUBLIC*** before it is submitted to the NRNA NCC-USA Election Commission; therefore, you must print it out and sign it **INFRONT OF A NOTARY PUBLIC** before emailing a scanned, signed copy.

Note: Please deposit \$100 for each complaint to NRNA NCC-USA's PayPal account. Deposit will be reimbursed if your claim deemed to be true.
