7.1 Fake Facebook ID Allegation

The executive board received a complaint against Spokesperson Mr. Om Bhattrai and Advisor Mr. Shiva Malla, which was submitted by Prasanna Sangraula, accusing they involve in the operation of a fake Facebook account named "Shidha Kura," and also accused they have involved the defamation of the community members through that fake Facebook account.
