Discussion and decision:

22.1 Discussion on project proposal

NRNA NCC USA received the project proposal from NIC-Nepal (National Innovation Center Nepal). The executive board discussed the project proposal and decided to support NIC-Nepal. The NCC USA will review the project proposal and will sign an MOU with NIC-Nepal the proposed total amount of twenty thousand dollars.

22.2 Discussion on Covid19 Nepal Oxygen project

The executive board discussed the COVID-19 crisis in Nepal. The executive committee decided to install the Oxygen plant in Nepal at a total value of one hundred twenty-five thousand dollars. To initiate this project NCC USA will work jointly with the ICC (International Coordination Council). Treasurer will coordinate with the president and will send the total cost of the oxygen plant amount within one week.

22.3 Discussion on ICC delegates selection and election process

The executive committee discusses the process of the ICC delegates selection process as ICC delegate guideline. Board decided to include the NCC USA elect committee (2021-2023) under the 65% delegates and conduct the 25% election on or before July 2nd, 2021.
